

**PARA WISE COMMENTS OF (RESPONDENT NO.4 AND 5)****RESPECTFULLY SHEWETH:**  
**PRELIMINARY OBJECTIONS:**

1. That the prayer in the Writ Petition does not hold water, as recommendation process has already been finalized by Khyber Pakhtunkhwa Public Service Commission for the post in question, hence this petition is not maintainable.
2. Khyber Pakhtunkhwa Public Service Commission is only a recommendatory body which purely acts on the requisition forwarded the concerned department.
3. That the petitioner has got no locus standi or cause of action against the replying respondents Khyber Pakhtunkhwa Public Service Commission as there is no post available / lying vacant.
4. That the petitioner has not approached this Honorable Court with clean hands as he tried to misguide the Honorable Court by twisting and distorting the facts and confusing the Public Service Commission Advertisement 01/2015 and 05/2018 with the Chief Executive / Principal, Saidu Teaching Hospital / Saidu Medical College adhoc post advertisement of 2015. The Writ Petition is not entertainable.
5. That the petitioner is estopped by his own conduct to file the instant petition.
6. That no discrimination / injustice have been done to the petitioner.
7. The petition is not based on facts, is unjustified and based on illegal demand against the lawful authority of the Commission.
8. That all the facts of the replying respondents are in line with the norms and principles of natural justice.

**ON FACTS**

1. Pertains to personal information of the petitioner. Needs no comments.
2. Correct to the extent that Khyber Pakhtunkhwa Public Service Commission advertised 01 post of male and 01 post of Female Warden vide Advertisement No. 01/2015, Serial No. 40 & 42 (**Annex-A**) against which proper recruitment process was finalized. The Commission initially recommended Miandad Khan who did not join and Sheraz Waheed was recommended against that who also did not join the post. Subsequently, the post of Male Warden fell vacant which on the request of Health Department was re-advertised by Khyber Pakhtunkhwa Public Service Commission vide Advertisement No. 05/2018 Serial No. 44 (**Annex-B**). Furthermore, the petitioner in the instant para is misleading the Honorable Court by confusing two advertisements at the same time i.e. one dated 01.01.2015 issued by Khyber Pakhtunkhwa Public Service Commission and the other published by office of the Chief Executive & Principal Saidu Teaching Hospital / Saidu Medical College Swat in newspaper whereby last date was 10.02.2015. Moreover, reply of respondent No. (06) regarding para 2 of facts of petitioner is very much clear in this regard.
- 3-5. Does not pertain to the replying respondent, Public Service Commission, as the petitioner in these paras is referring to the procedure that followed in light of the advertisement of Respondent No. (06) whereby vacancies were to be filled on Adhoc basis for a period of one year.
6. Correct to the extent that Khyber Pakhtunkhwa Public Service Commission recommended Mr. Sheraz Waheed after the non-joining of the initial recommendee, Mr. Miandad Khan for which inter-departmental correspondence is annexed as **Annex-C**. Moreover, after the post in question fell vacant, the Health Department sent a fresh requisition to the Khyber Pakhtunkhwa Public Service Commission and it was advertised vide

Advertisement No. 05/2018 S.No.44. Consequent upon completion of recruitment process Mr. Shah Zeb S/O Mohib Gul of Mohmand Agency has been recommended to Govt: for appointment vide letter No. PSC/SR-III/004901 dated 28.02.2020 (**Annex-D**). The mentioned recommendee has been appointed by the parent department vide letter No. **SOH-III (HD)2-18/2020** dated 17.04.2020 (**Annex-E**). Hence the recommendation of 01 requisitioned post of male warden has been finalized and the post of 01 female warden is still pending for recommendation on part of Khyber Pakhtunkhwa Public Service Commission. (Apart from this, the case pertaining to Mst. Azra as asserted by the petitioner does not pertain to Khyber Pakhtunkhwa Public Service Commission).

7. As earlier replied. The petitioner is deliberately confusing Public Service Commission's advertisement of 2015 and 2018 with the department's one year adhoc advertisement of 2015.
- 8-9. Does not pertain to the replying respondent Public Service Commission. Moreover, reply of Respondent No.6 regarding para 8-9 of facts of petitioner is very much clear in this regard.
10. Incorrect. The Khyber Pakhtunkhwa Public Service Commission has recommended Mr. Shah Zeb S/O Mohib Gul vide letter No. PSC/SR-III/004901 dated 28.02.2020 in response to advertisement No. 05/2018 S.No.44. Hence the petition is infructuous in the eyes of Law.

- a. Incorrect. The petitioner again misstated the facts in this para as Khyber Pakhtunkhwa Public Service Commission has already recommended Mr. Shah Zeb S/O Mohib Gul of Mohmand Agency as male warden in Saidu Medical College Swat to the Govt: for appointment vide letter No. PSC/SR-III/004901 dated 28.02.2020, against advertisement No. 05/2018 S.No.44.

- b. Incorrect. No post is lying vacant as already explained in para 6 of the facts.
- c. Incorrect. As explained in para 10.
- d. Does not pertain to Public Service Commission.
- e. Incorrect. The replying respondent acted according to law. No violation of any right of the petitioner was ever committed.
- f. Incorrect. The Public Service Commission has already finalized and forwarded its recommendations to the department in response to requisition in case of Male Warden.
- g. Incorrect. No misuse of authority has ever been committed by the Khyber Pakhtunkhwa Public Service Commission in case of the petitioner.
- h. Public Service Commission is a recommendatory body having already done its part of the job according to Law.
- i. That the petitioner not been genuinely aggrieved person, may not be allowed to raise further grounds before this August Court.

It is therefore humbly prayed that on acceptance of this reply/submission made herein above the instant petition may kindly be dismissed.

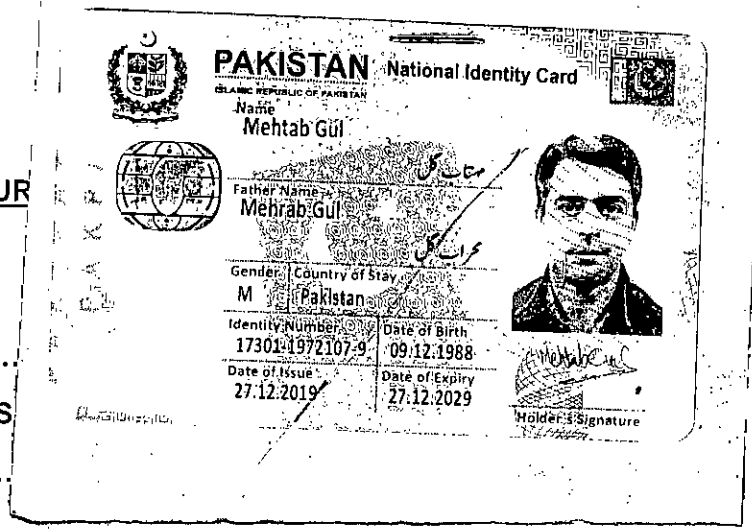



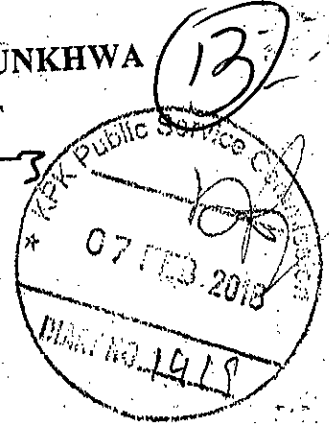
